GENERAL MEDIA AGREEMENT

To support the Client's air sampling project, Eurofins | mgt provides the media necessary for sample collection. Air sampling media may include evacuated canisters, flow controllers, and vacuum gauges.

Media should be returned to the laboratory within **15** days of receipt. Evacuated canisters have a finite timeframe before the canisters naturally lose vacuum during storage. Using canisters beyond **15** days increases the risk of having unacceptable initial vacuum at the start of sampling.

This risk increases the longer the canisters are in the field. Eurofins | mgt does not guarantee canister vacuum after **30** days.

Failure to return media within **21** days of receipt will result in a **AU\$50^{.00}※** / week charge for extended use. Failure to return media within **45** days of receipt will result in invoicing of the replacement cost of outstanding media to the customer's project.

Additionally, the Client is responsible for returning equipment in substantially the same condition as when received from Eurofins | mgt. Damaged or unreturned media will be charged to the customer as outlined in the table below.
