Initial production inspection

Also called pre-production inspection, this takes place before production kicks off. By checking the incoming quantity, quality, styles, and other details of the raw materials, as well as production equipment, it ensures your production starts in the right place.

Fabric inspection

For garment suppliers, it is crucial to ensure the quality of the main materials – fabric. By using the 4-point system, we identify defects of fabrics to lower the risk of product rejection in later production stages.

During production inspection

With ANSI/ASQC Z1.4 (ISO 2859), we ensure your production is taking place properly, and you will be receiving your products as matching the samples you approved. During the inspection, we can also perform sample picking and on-site basic product testing. In addition, we offer Inline Inspection that provides extra assurance on product quality.

Final random inspection

After completion of production, you can conduct quality and packaging check inspections on finished goods before they go into shipping containers.

Loading supervision

As a final round of inspection, our inspectors will check packing details and quantity against documentation about at loading.
