Application security

Complete visibility of client-side security, with real-time threat detection and callbacks for automated reactions.

Network monitoring

A component that (passively) monitors the security of managed and (un)managed (IT/OT) hosts and devices.

Device security

Protect you and your network infrastructure from unsecure (un)known devices.
