Statements of the ALS

The Working Group of Food Chemistry Experts from the Federal States and the Federal Office of Consumer Protection and Food Safety (ALS) adopted the following opinions during its 124th meeting:

Decision Tree "Naturalness of Food Additives" under Regulation (EC) No. 1333/2008:

The ALS has published a decision tree to help ascertain whether a food additive should be classified as "natural," the ALS has published a decision tree (Statement No. 2025/01).

Foods for Special Medical Purposes (balanced diets) for individuals with chewing and swallowing difficulties:

Pureed ready meals shaped using thickening agents for individuals with chewing and swallowing difficulties meet the requirements for foods for special medical purposes and may be marketed under the designation "Food for Special Medical Purposes (balanced diet)" (Statement No. 2025/02).

Joint supplements marketed as food supplements with authorised health claims relating to connective tissue, cartilage or bones:

The product name "Joint ..." or corresponding graphic representations may, depending on the type of presentation/advertising, violate various provisions of the Health Claims Regulation (Regulation (EC) No. 1924/2006, HCVO) (Statement No. 2025/03).

Advertising food supplements with a nutrient transport concept:

Highlighting a nutrient transport concept emphasises a special product feature. If the product owner cannot sufficiently substantiate this scientifically, the claim is misleading. Mentioning a nutrient transport concept without further explanation on the labelling does not comply with the relevant provisions of the Food Information Regulation (LMIV) (Statement No. 2025/04).

Assessment of health/disease-related claims made in customer reviews on the distributor's website:

By publishing customer reviews on their own website, the distributor assumes responsibility for the content of the statements. Violations of the LMIV or HCVO provisions are therefore attributable to the distributor, even if a disclaimer is used (Statement No. 2025/05).

Amino acid profile - Nutritional or quality-related claim?

If the labelling of protein-containing foods includes a voluntary statement on the amino acid composition per 100 g of protein in addition to the nutritional information, and no individual amino acids or amino acid groups are highlighted, this is considered a quality-related claim (Statement No. 2025/06).

EFSA publications

The European Food Safety Authority (EFSA) has published the following:

Neotam (E 961):

As part of the re-evaluation of Neotame as a food additive, a new Acceptable Daily Intake (ADI) of 10 mg/kg body weight per day was established. This replaces the previously set value of 2 mg/kg body weight per day (https://www.efsa.europa.eu/de/efsajournal/pub/9480).

Fluoride:

The potential risks of fluoride in drinking water, food, fluoridated table salt, and swallowed fluoridated dental products for consumers were re-evaluated. Safe/acceptable intake levels for all age groups were updated (https://www.efsa.europa.eu/en/news/fluoride-safety-updated-intake-levels-all-ages).

Lead:

EFSA has published its assessment of dietary exposure to lead for the European population. In adults, meat-based foods contributed most to lead exposure https://www.efsa.europa.eu/de/efsajournal/pub/9577.

The Federal Institute for Risk Assessment (BfR) has published the following, among others:

Fly Agaric Poison – Health Risks of Muscimol-containing "Fruit Gummies":

In its statement dated 27 June 2025, the BfR warns against consuming products resembling fruit gummies that contain the intoxicating fly agaric poison Muscimol. Children are particularly at risk. Changes in plant protection products

Maximum residue levels (MRLs):

Regulations (EU) 2025/1212 and 2025/1305 amended the MRLs for the following active substances:

Acetamiprid, amidosulfuron, azoxystrobin, hexythiazox, isoxaben, sodium silver thiosulphate, picloram, propamocarb, and tefluthrin.

Judgements

ECJ – Unauthorised organic advertising for medicinal tea:

Traditional herbal medicinal products may not be labelled with the EU organic logo. According to the ECJ, such products fall exclusively under EU pharmaceutical law. (ECJ, judgement of 26 June 2025, C-618/23 – SALUS, https://curia.europa.eu/juris/document/document.jsf?mode=DOC&pageIndex=0&docid=301744&part=1&doclang=EN&text=&dir=&occ=first&cid=10299241).

Federal Constitutional Court - "Food Pillory":

If an unreasonably long period elapses between the food control complaint and its publication online, this violates the provisions of the Basic Law. "Dubai Chocolate" - update:

Contrary to the decision of the Cologne Regional Court dated 26 February 2025, the Cologne Higher Regional Court ruled in an urgent procedure that "Dubai Chocolate" may only be labelled as such if it is actually produced in Dubai. Misleading advertising with regionality:

The claim "from regional farms" for sausage products was misleading, as the products were available nationwide online. It could not be guaranteed that buyers would receive goods from their own region. Unauthorised designations such as "This is not Gin":

According to a ruling by the Hamburg Regional Court, alcohol-free alternatives to spirits may not contain designations protected by the Spirits Regulation. The use of the English word "not" does not prevent this prohibition. "Immune-Smoothie" - unauthorised:

A fruit puree with added vitamins may not be marketed as an "Immune Smoothie." According to the Karlsruhe Regional Court, the term "Immune" constitutes an unauthorised health claim. Fruit puree with added vitamins may not be marketed as an "immune smoothie." Miscellaneous

Novel Food - Extension of the Union List:

Commission Implementing Regulation (EU) 2017/2470 establishing the Union list of novel foods has been amended by further implementing regulations, granting the following approvals:

- Roasted seeds of the Baru nut (Dipteryx alata Vogel) as a traditional food (Implementing Regulation (EU) 2025/1263 of 30 June 2025),
- Oil from tiger nut/earth almond (Cyperus esculentus) as a novel food (Implementing Regulation (EU) 2025/1528 of 30 July 2025).

Additive polyvinylpolypyrrolidone (E 1202):

Regulation (EU) 2025/1337 of 10 July 2025 authorised polyvinylpolypyrrolidone (E 1202) as a carrier in dye tablets for colouring poultry eggshells.
