









Swimming Pools and Recreational **Bathing Facilities**

Swimming pool monitoring requirements vary depending on locations. Eurofins QC provides sampling and analysis services to commercial recreational water clients who are required to demonstrate compliance with state and county health department requirements for recreational bathing in Pennsylvania and New Jersey.

Services are provided to hotels, motels, private swim clubs, municipal pools and commercial pool management companies. Samples collected for microbiological analysis are transported to a conveniently located Eurofins QC facility for immediate analysis. Non-compliant microbiological data are promptly reported to the client and the appropriate regulatory authority enabling the client to initiate corrective action.

Our customer service and laboratory personnel have extensive experience with state and local requirements for pool sampling. Specific regulatory requirements for recreational waters monitoring within the Eurofins QC service area are available through our customer service representatives.

As of January 16, 2018 the New Jersey Department of Health has updated their State Sanitary Code, Chapter IX, Public Recreational Bathing (N.J.A.C 8:26), regarding sample collection and analysis. Please contact your Client Service Representative with any questions.

Overview of Regulatory Requirements for Pool Sampling and Analysis

Facility Location/Type	Required Tests
New Jersey: Lake	E. coli, pH (Bays and oceans require Enterococcus)
New Jersey: Pool	Total Coliform, Heterotrophic Plate Count (HPC), pH, Chlorine or Bromine*
New Jersey: Spa	Pseudomonas, HPC, Chlorine or Bromine*
Pennsylvania: Lake	E. coli, pH
Pennsylvania: Pool or Spa	Coliform, pH, Chlorine or Bromine*
Pennsylvania: Pool or Spa - Bucks County	Coliform, HPC, pH, Chlorine or Bromine*
