On April 21, 2026, the Louisiana Environmental Laboratory Accreditation Program (LELAP) received a renewal application for environmental laboratory accreditation.

The Louisiana Department of Environmental Quality's laboratory accreditation program, in accordance with Louisiana Administrative Code (LAC), Title 33, Part I, Subpart 3, Laboratory Accreditation, accredits this laboratory from July 1, 2026 to June 30, 2027. This accreditation does not constitute an endorsement of the suitability of the listed methods for any specific purpose. Accreditation of the environmental laboratory does not imply that a product, process, system, or person is approved by LELAP.

LELAP grants accreditation for those methods/analytes as indicated by the accreditation type on the attached scope of accreditation.¹ Accreditation is dependent on the laboratory's successful ongoing compliance with regulations as outlined in the Louisiana Administrative Code, Title 33, Part I, Subpart 3, Laboratory Accreditation and with the policy, rules, or standard of any other accreditation body (AB) listed on the scope of accreditation, as applicable.
