WHY BECOME A BRC GLOBAL STANDARDS PROFESSIONAL?

As a BRC Global Standards Professional you will be well-equipped to manage any GFSI-recognised Standard in your business, and able to implement or manage product safety systems.

BRC Global Standards is the leading provider of GFSI-recognised Standards globally, respected for quality and brand protection assurance.

This training programme has been designed by the BRC Global Standards Technical team in response to demands from the industry for training on the skills necessary to implement effective product safety management.

Gaining certification as a BRC Global Standards Professional will:

- enhance your understanding of product safety management;
- enable you to apply skills to reduce risks associated with product safety;
- enable you to contribute as part of the brand protection team your company needs; and
- raise your status as a valuable employee.



WHAT COURSES ARE INCLUDED IN THE PROGRAMME?

Delegates must complete 1 of the following:

- An 'Understanding the requirements' course relevant to any of the BRC Global Standards (2 days) OR
- An 'Implementing the Standard' course relevant to any BRC Global Standard (2 days)

PLUS 1 of the following from the BRC Global Standards Academy or similar training provider:

- HACCP course (2 days)
- Hazard and risk management course (2 days)
- HARPC course (2 days)
- FSPCA PCQI course (2.5 days)

PLUS 3 of the following BRC Global Standards Academy courses:

- Risk assessment (1 day)
- Root cause analysis (1 day)
- Validation and verification (1 day)
- Internal auditor (2 days)

On completion of the required courses, candidates will be awarded with a BRC Global Standards Professional certificate and an electronic open badge for use on emails and LinkedIn.



WHO IS IT FOR?

All product safety personnel in food, packaging, storage and distribution and related industries; for example, quality assurance managers, food technologists, category technologists and HACCP teams.

Your company does not have to be certificated against the BRC Global Standards.

The courses are subject-specific, train the core skills needed for any product safety individual, and will help with maintaining any GFSI-recognised certification scheme.



WHERE ARE THE COURSES RUN?

Courses are run by the BRC Global Standards Academy, and via the BRC Global Standards Approved Training Providers (ATPs) globally. All courses and ATPs are listed at www.brcglobalstandards.com/training

When registering for your course, it is essential to ensure your trainer is a BRC Global Standards ATP, as only BRC Global Standards Academy courses will be accepted for this programme (with the exception of HACCP, HARM, HARPC and PCQI courses).



HOW LONG DOES IT TAKE?

The total programme would take 8-9 days to complete, however courses can be completed in any order, and at times and dates to suit over the course of the year.



HOW MUCH DOES THE TRAINING COST?

Annual subscription for BRC Global Standards Professional costs £80. This includes registration of all your completed courses; your open badge; certification of all successful course completions; as well as access to exclusive webinars run by the BRC Global Standards Technical team; a regular newsletter; and discounts on BRC Global Standards events, Bookshop and Participate.

Course fees are additional to the subscription fee and will vary depending on your provider.
