We offer a full suite of chemical and microbiological analyses aligned to BSRIA guidance for both commissioning and routine monitoring.

Microbiological analysis includes:

- Total Viable Counts (TVCs)
- Pseudomonas* species
- Sulphate Reducing Bacteria (SRB)
- Nitrite Reducing Bacteria (NRB)

Chemical analysis includes:

- pH, conductivity and alkalinity
- Corrosion metals: iron, aluminium, copper, zinc
- Molybdate, nitrite inhibitors
- Film forming amines
- Anions: chloride, sulphate, nitrate
- Total Suspended Solids (TSS)
- Total Dissolved Solids (TDS @105°C)

Why test closed systems?

Closed water systems (e.g. heating and chilled water circuits) are vulnerable to corrosion, scale formation and microbial growth if water chemistry and microbiology are not correctly controlled. Poor water quality can lead to:

- Reduced energy efficiency
- Premature plant failure
- Blocked strainers and valves
- Biofouling and microbiologically influenced corrosion (MIC)

Regular testing helps demonstrate compliance, confirm inhibitor performance and identify issues early; before they become costly problems.
